A & B Pro Guides (ABPG) is a growing network of Oregon and Washington licensed guides and charters who have agreed to accept client referrals through our service. ABPG helps fill the gap for those looking for a fishing trip, but are not sure what species or location to fish and are not sure how to locate a quality guide.

Our job is to help arrange trips for families, business groups and individuals directly with the guide or charter service that best fit their needs and can insure the highest chance of success. We are also here to insure that our clients take their trip with a safe, qualified, licensed guide with the highest amount of favorable feedback from past clients.

ABPG provides all clients with a detailed map and driving directions to the meeting location. We also offer many other amenities including private round trip transportation services as well as information on nearby lodging and fish processors.

We collect a small deposit from the client (typically 10% of the total trip price). We then begin researching guides that best fit our clients needs. When a guide with open seating is located we reserve the seats with the guide and send a confirmation letter to the client that contains all contact information for the guide, meeting time and map and driving directions to meeting location.

Availability of open seats, dates etc. will be verified with each guide prior to all bookings. Guides will also receive a copy of the confirmation letter with all of the clients contact information, email, physical address, date of trip, etc.

We occasionally utilize photos from our members; we either cull these photos from their Web sites or request them by email. These images are placed on our site abproguides.com to promote the various fisheries throughout Oregon and Washington.

If you agree to becoming a member of A & B Pro Guides referral service we would be happy to continue sending clients your way and welcome you to our network of over 180 Oregon and Washington guides and charters. A flat 10% tour operator's fee will be charged for each client referral that books a trip. No fees are charge for ocean charters. Guides who have their Web sites hosted and/or maintained through ABPG receive the first chance at all referrals. Next on our list are guides and charters who have the highest amount of positive client feedback.

In regards to search engine submission and rankings; with your new site we include free monthly submission to over 300 of the top search engines. In addition, we also offer paid submission options that have proven cost effective for many of our current customers. Cost for this service is \$18.00 per month or choose our Extreme Submission plan for \$250.00 per year.

We also alter and optimize the HTML code on every page of every site we design to insure the best rankings possible.

If you do not have a domain name we can provide one **free** with your site. In addition we can also offer you rental of one of more top domain names for your site. Cost: Only \$35.00 per year.

These domains contain keywords that are often used to search for guides in the northwest and therefore rank high in the search engines when combined with a like site.
